The undersigned is directed to say that The Royal Thai Government has invited **one nomination** for the **fully funded** subject long term training course under University of Thai Rangsit University, Institute of Diplomacy and International Studies. 2. All the expenses involved on account of tuition fees accommodation insurance and return airfare will be borne by the Royal Thailand government.

3. The eligibility criteria and objectives of the Training course are as under:

Eligibility Criteria

- Be nominated by their respective government.
- Hold a bachelor's degree.
- Be under 40-45 year of age.
- Proficient command of the English language (a TOEFL score of at least 550 or its equivalent).
- In case applicants do not possess the requisite test score, they may take Rangsit University's English placement test. Those who do not pass the English placement test will be required to take a remedial English language course.
- Be in good health, both physical and mentally.

Objectives


- To produce professionals for positions of leadership and influenced in foreign affairs and international business.
- To promote the international cooperation, in particular among Asian countries.
- To foster networking among its alumni, professionals and scholars in international affairs
- To pursue deep understanding of international issue and concerns through advanced learning and scholarly research.

- To promote foreign language learning.
- To provide both academic and practical skills (e.g. negotiation techniques, diplomatic practices, rhetoric, media skills) for established diplomats and officials at the early to mid-career level in particular those from the new members of ASEAN.
- To provide academic and practical skills to business executive (e.g. negotiation techniques, international practices and norms in communicating with business, rhetoric, media skills)to help bring Thai business into international markets.
