- **B. Acc:** The program takes into consideration an accountant's role in maintaining records of financial transactions affecting organizations, reporting the results of operations and information technology in professional applications.
- The program focuses on particular aspects of accounting which enable students to gain the knowledge and skills necessary to become an accounting professional.


