This information pertains to one of the Training and Dialogue Programs of the Japan International Cooperation Agency (JICA), which shall be implemented as part of the Official Development Assistance of the Government of Japan based on bilateral agreement between both Governments.

I. Concept

Background

The World Trade Organization (WTO) was established in 1995 and 157 member countries and regions have joined as of the end of 2011 including Russia, Montenegro and Samoa, of which memberships was approved in the Eighth Ministerial Conference in December last year. However, there are about 26 countries still making efforts to gain membership of the WTO. In addition, even as for the WTO member countries, they are having some difficulties in actual implementation of the WTO agreements under the situation that only about 100 countries have reported their domestic acts to the WTO so far in the world.

As one of the technical cooperation to developing countries in this field, JICA implemented "Operation of Understanding on Rules and Procedures Governing the DSU, WTO Agreements" course annually since 2001 till 2010, but which focused on the DSU only.

It is still recognized that to promote understandings of basic agreements of all the WTO agreements and important terms for them is an urgent issue in developing countries, in order to expand trade and investment for their countries, to develop economy along with the expansion of trade and investment, and then to strengthen their international trading system.

Therefore JICA started this course in 2010.

For what?

Participants are expected to acquire basic and applicable knowledge of the WTO agreements and improve their capabilities.

For whom?

Officials of Governmental organizations or relevant organizations related to the administration of the WTO agreements.

How?

Through lectures and site visits conducted by related professors and professionals in Japan.

The participants are requested to hold a dissemination meeting in the respective organization in order to share knowledge or experience they gain in the Core Phase in Japan with their colleagues and people related to the WTO. The participants need to write and submit a report of this dissemination meeting to JICA up to <u>August 31, 2012</u>.

III. Conditions and Procedures for Application

1. Expectations for the Participating Organizations

- (1) This program is designed primarily for organizations that intend to address specific issues or problems identified in their operation. Participating organizations are expected to use the program for those specific purposes.
- (2) This program is enriched with contents and facilitation schemes specially developed in collaboration with relevant prominent organizations in Japan. These special features enable the program to meet specific requirements of applying organizations and effectively facilitate them toward solutions for the issues and problems.
- (3) As this program is designed to facilitate organizations to come up with concrete solutions for their issues, participating organizations are expected to make due preparation before dispatching their participants to Japan by carrying out the activities of the Preliminary Phase described in section II-9.
- (4) Participating organizations are also expected to make the best use of the results achieved by their participants in Japan by carrying out the activities of the Finalization Phase described in section II-9.

2. Nominee Qualifications

Applying Organizations are expected to select nominees who meet the following qualifications.

(1) Essential Qualifications

- 1) Current Duties: the governmental or relevant organization officials engaged in the work related to the WTO and expected to be engaged in this field in the future
- 2) Experience in the relevant field: should have more than three (3) years of occupational experience in this field
- 3) Educational Background: graduated of faculty or university in the field of Law or Economics
- 4) Age: be between the ages of thirty (30) and forty-five (45) years in principle
- 5) Language: have a competent command of spoken and written English which is equal to <u>TOEFL IBT 100 (CBT 250, PBT 600) or more</u> (This course includes active participation in discussions. Therefore it requires high competence of English ability. Please attach an official certificate for English ability such as TOEFL, TOEIC etc, if possible)

Please note that the competent English ability is essential for this course.

6) Health: must be in good health, both physically and mentally, to participate in the Program in Japan

And,

- 7) Must not be serving any form of military service.
- *There is higher risk for pregnant women and people with chronic diseases to cause serious medical consequences when infected with the new Influenza A (H1N1) virus according to the past cases. Under the pandemic situations of the new Influenza, pregnant applicants shall not be accepted for the time being. And applicants who suffer from chronic diseases, such as respiratory illness, cardiac disease, metabolic disease

(diabetes, etc), renal dysfunction and immune insufficiency (systemic steroid administration, etc), shall not be accepted in principle.

However, for those applicants with the chronic diseases, if they and their organizations express strong interest in participating in training programs, JICA shall accept them as an exceptional case after receiving a letter of consent from themselves and their organizations.

Please ask national staff in JICA office for the details.

3. Required Documents for Application

Each applicant is requested to prepare a Country Report and an Inception Report and submit them together with the Application Form. In your organization chart, please indicate your position, starting from the section of the lowest level of your organization and circle the section you belong to.

Any application not accompanied by a Country Report nor an Inception Report shall not be considered as duly qualified.

4. Procedure for Application and Selection

(1) Submitting the Application Documents:

Closing date for application to the JICA Center in JAPAN: <u>March 27, 2012.</u> Note: Please confirm the closing date set by the respective country's JICA office or Embassy of Japan of your country to meet the final date in Japan.

(2) Selection:

After receiving the document(s) through due administrative procedures in the respective government, the respective country's JICA office (or Japanese Embassy) shall conduct screenings, and send the documents to the JICA Center in charge in Japan, which organizes this program. Selection shall be made by the JICA Center in consultation with the organizations concerned in Japan based on submitted documents according to qualifications.

The organization with intention to utilize the opportunity of this program will be highly valued in the selection.

(3) Notice of Acceptance

Notification of results shall be made by the respective country's JICA office (or Embassy of Japan) to the respective Government by not later than <u>April 13, 2012</u>.

5. Conditions for Attendance

(1) to observe the schedule of the program,

- (2) not to change the program subjects or extend the period of stay in Japan,
- (3) not to bring any members of their family,
- (4) to return to their home countries at the end of the program in Japan according to the travel schedule designated by JICA,
- (5) to refrain from engaging in political activities, or any form of employment for profit or gain,
- (6) to observe Japanese laws and ordinances. If there is any violation of said laws and ordinances participants may be required to return part or all of the training expenditure depending on the severity of said violation,
- (7) to observe the rules and regulations of their place of accommodation and not to change the accommodation designated by JICA, and
- (8) To participate the whole program including the preparatory phase prior to and the finalization phase after the core phase in Japan.

JICA and Capacity Development

The key concept underpinning JICA operations since its establishment in 1974 has been the conviction that "capacity development" is central to the socioeconomic development of any country, regardless of the specific operational scheme one may be undertaking, i.e. expert assignments, development projects, development study projects, training programs, JOCV programs, etc.

Within this wide range of programs, Training Programs have long occupied an important place in JICA operations. Conducted in Japan, they provide partner countries with opportunities to acquire practical knowledge accumulated in Japanese society. Participants dispatched by partner countries might find useful knowledge and recreate their own knowledge for enhancement of their own capacity or that of the organization and society to which they belong.

About 460 pre-organized programs cover a wide range of professional fields, ranging from education, health, infrastructure, energy, trade and finance, to agriculture, rural development, gender mainstreaming, and environmental protection. A variety of programs and are being customized to address the specific needs of different target organizations, such as policy-making organizations, service provision organizations, as well as research and academic institutions. Some programs are organized to target a certain group of countries with similar developmental challenges.

Japanese Development Experience

Japan was the first non-Western country to successfully modernize its society and industrialize its economy. At the core of this process, which started more than 140 years ago, was the "adopt and adapt" concept by which a wide range of appropriate skills and knowledge have been imported from developed countries; these skills and knowledge have been adapted and/or improved using local skills, knowledge and initiatives. They finally became internalized in Japanese society to suit its local needs and conditions.

From engineering technology to production management methods, most of the know-how that has enabled Japan to become what it is today has emanated from this "*adoption and adaptation*" process, which, of course, has been accompanied by countless failures and errors behind the success stories. We presume that such experiences, both successful and unsuccessful, will be useful to our partners who are trying to address the challenges currently faced by developing countries.

However, it is rather challenging to share with our partners this whole body of Japan's developmental experience. This difficulty has to do, in part, with the challenge of explaining a body of "tacit knowledge," a type of knowledge that cannot fully be expressed in words or numbers. Adding to this difficulty are the social and cultural systems of Japan that vastly differ from those of other Western industrialized countries, and hence still remain unfamiliar to many partner countries. Simply stated, coming to Japan might be one way of overcoming such a cultural gap.

JICA, therefore, would like to invite as many leaders of partner countries as possible to come and visit us. to mingle with the Japanese people, and witness the advantages as well as the disadvantages of Japanese systems. so that integration of their findings might help them reach their developmental objectives.
