Eligibility Criteria

- Be a female applicant (Ewha is not a co-ed university)
- **Be less than 40 years old**
- Be in good health, both physically and mentally, to complete the program
- Be a citizen of the Scholarship Program partner country
- Be a government official or an employee in the public sector with a Bachelor's Degree or higher approved by the government
- Be nominated by the Government
- Have sufficient command of both spoken & written English to take classes conducted entirely in English, and to write thesis in English
- Not have participated in a KOICA Scholarship Program

- Provide high quality education for women professionals with theoretical and practical skills and knowledge of development to enhance gender equality and empowerment of women in developing countries.
- Develop leadership capacity of women officials in public sector so that they can play key roles in the development process of their countries.
- Share Korea's development experience which can be applied not only to achieve the economic development but also to improve the conditions of women in participants' countries
- Build a cooperative relationship between Korea and partner countries through the global network of women leaders

- Sufficient command of spoken and written English to succeed in a graduate-level academic environment;
- Excellent mental and physical health;
- Preferably be **under 40 years** of age;
- Have not previously received a scholarship from the Korean government;
- Have never withdrawn from KOICA's scholarship program due to submission of false documents, below average school performance, or violation of school regulation;
- Expected to work in a related field for at least one year upon graduation.

Objective:


- Enhancing understanding of the Korean experience of economic development and economic cooperation;
