

- Be preferably under 40 years.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Have not participated in KOICA's scholarship program or any of the Korean government's scholarship program before (especially in a Master's degree program).

- Deepen knowledge and insights of government officials from developing countries in agri. Products processing and marketing.
- Obtain hands on experience of his her own major and strengthen practical capabilities by a combination of class and industry activity.
- Expand available resources and personnel network in partnership with Konkuk University and other Korean institutes.
