Participant's qualifications and requirements for Admission are:-

- Officials/technicians from relevant departments / institutions
- Under 55 years old for Director General and 50 for Director
- Proficiency in English
- In good health free from any infectious disease

Papers to be prepared by the participants

- Introduction relevant to the Seminar from Pakistan (10 to 20 pages in writing, computer diskette or CD-ROM)
- Other documents that the participants consider useful for presentations
- Four passport photos and name cards.

Expenses

The following expenses are to be borne by MOFCOM for the participants:

- Round-trip air tickets and transit allowance.
- Board and lodging in China. (alcoholic drinks excluded)
- Local transportation fees incurred of all activities arranged by the Chinese organizer.
- Pocket money of 80 Yuan RMB per head per day for officials and technicians respectively.

The following expenses are to be borne by the Participants themselves:

- Excessive luggage charge during international and domestic travels.
- Post and telecommunications, passport make and visa issuance.
- Buy spectacles, see the dentist, or go to beauty saloon.
- Examination, diagnosis, treatment and medicine of any chronic disease.

2. The following documents must be submitted by the deadline without which nominations may not be considered by the EAD:

- Information Form duly filled in by the nominee with office, residence and mobile phone number and fax numbers (two sets)
- Undertaking form (two sets)
- Surety Bond (two sets)
- Two copies of valid passport.
- NOC or undertaking by the nominating authority that once nominated the candidate will not be withdrawn after selection.
