

- Introduce key areas of private sector development and entrepreneurship
- Explain stages of private sector development linking to SMEs and innovation.
- Promote FDI and private sector development through bilateral investment guarantee agreements and free trade agreements.
- Share Singapore experiences in development SMEs with SPRING Singapore as the lead agency.
- Explain the development of Public Private Partnership as an important contributor for economic growth for developing economies.
