Economic Affairs Division's has informed that the Civil Service College, Singapore has invited four nominations for the **partly funded** training course on **“3<sup>rd</sup> Temasek Foundation Leaders in Economic Development (TFLED)”** scheduled to be held from **14<sup>th</sup> to 22<sup>nd</sup> March, 2016** in Singapore.

2. The eligibility criteria for the subject training course are given below:-
- i. There should be a minimum of 2 and a maximum of 4 participants per team. All members of the team should preferably be from the same organisation.
  - ii. At least one team member should be a senior official at the Permanent Secretary, Deputy Secretary, Director General, Additional Secretary level or above.
  - iii. Each team has to identify a project related to the topic of economic development that they will work on during the programme.
  - iv. Nominated by their respective Government.
  - v. Proficient in spoken and written English.
  - vi. In good health

3. It may be noted here that the training course is **partly funded** as the programme fees, accommodation and learning journey expenses will be borne by the organizers, **however, round-trip air tickets, visas and personal expenses including per diem allowance will not be provided.**

4. It is therefore requested that the nominations of officers duly approved/endorsed by the respective heads of wings may kindly be forwarded to the u/s **along with training Performa as circulated by the Admn-I Section on 02-07-2015** today before close of office hours for onwards submission to the EAD, Islamabad.

**Eligibility Criteria**

- There should be a minimum of 2 and a maximum of 4 participants per team. All members of the team should preferably be from the same organisation.
- At least one team member should be a senior official at the permanent Secretary, Deputy Secretary, Director General, Additional Secretary level or above.
- Each team has to identify a project related to the topic of economic development that they will work on during the programme.
- Nominated by their respective Governments
- Proficient in spoken and written English.
- In good health


**Objectives**

Each team is expected to bring with them an issue/challenge that the team is currently facing to seek feedback and ideas from resource experts and fellow participants. It must be related to the topic of economic development, and endorsed by a senior management member of the organization. The aim is for each team to come up with proposed plan of action to address their issue/challenge at the end of the programme.

3. Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority alongwith following documents may be forwarded to this Division by **12 January, 2015** positively.

1. Team Project Description
2. Individual Background information (with brief information sheet on the mission and role of your organization).
3. Nominating Authority's Recommendation
4. Applicant's letter of undertaking
5. An Undertaking by the participant to bear Round Trip Airfare. One copy (original)
6. Passport Copy One copy
7. Copy of National Identity Card One copy

4. Incomplete/late submission of documents/nomination will not be entertained. Moreover, any deliberate provision of wrong information on the part of the candidate shall be viewed seriously.
