



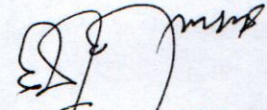

The participants are expected to refresh their professional knowledge for better understanding to application of rules on the subject..

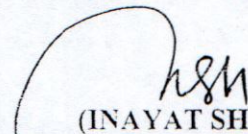

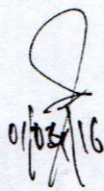

This course is designed for government officers in BS-17 to BS-19.

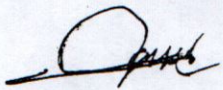
