SUBJECT:- POSTING OF ECONOMIC MINISTER (BS-20), EMBASSY OF PAKISTAN, TOKYO, JAPAN.

The undersigned is directed to invite nominations of suitable BS-20 officers to fill up the post of Economic Minister at the Embassy of Pakistan, which will fall vacant shortly. Policy guidelines issued vide Establishment Division's O.M.No.4/7/81-T.IV, dated 28th December, 1981, as summarized below, may be taken into consideration while nominating officers for the subject post:-

- The nominees fulfils requirements of the post as detailed in the Job Description (Annex-I).
- b) The nominees is in the same pay scales as the post to be filled. Officers from higher or lower pay scales will not be considered.
- c) The nominee has an overall good record of service, particularly during the last five years of service.
- d) The nominee is at least a graduate, or possesses equivalent qualification.
- e) Persons within promotion zone within the next two years will not be considered.
- f) Those likely to retire during the next four years will not be considered.
- g) An officer should not be posted abroad more than once.
- 2. All the Ministries/Divisions and Provincial Governments are requested to send nominations of suitable BS-20 officers to this Division, along with the following documents (in duplicate):
 - i) Bio-data as per Annex-II.
 - PER Synopsis for the last five years.
 - iii) A certificate to the effect that no disciplinary proceedings are pending against the nominee (in respect of APUG officers such certificates shall be issued by the Establishment Division).

3. All Ministries/Divisions and the Provincial Governments are requested to forward suitable nominations in duplicate duly complete to Finance Division (HR-I Section), "Q" Block, Pak. Secretariat, Islamabad by 27th November, 2015. Incomplete nominations and those received after November 27, 2015 will not be entertained.

Job Description of the Economic Minister at Tokyo, Japan

- The Economic Minister will keep himself abreast of the political economy of the Japan and send regular/ periodic briefs to finance division on all relevant developments/ issues.
- 2. Promotion of Pakistan-Japan economic ties.
- 3. Liaise with Funding agencies like JAICA to ensure a smooth relationship between Pakistan and Japanese funding agencies.
- 4. Coordination of any bilateral trade or economic cooperation agreements between Pakistan and Japan.
- 5. Promote investment in Pakistan Japan.
- Play a role in negotiation of free trade and preferential trade agreements, and accords covering investment, double taxation avoidance and other financial services.
- All other matters incidental and ancillary to the above.
- 8. Submit a quarterly report to the Finance Division, stating progress and achievements in the above mentioned duties through Embassy of Pakistan, Tokyo, Japan.
