# SUBJECT: NOMINATIONS FOR SELECTION OF THE POST OF ASSISTANT ACCOUNTS OFFICER (BS-17), AT THE DIRECTORATE GENERAL OF HAJJ, JEDDAH, SAUDI ARABIA.

The post of Assistant Accounts Officer (BS-17) in the Directorate General of Hajj. Jeddah. Saudi Arabia is required to be filled in by a suitable officer through a process of selection as per prescribed policy in this regard. Job Description of the post is as undert-

- Pre-audit of all payments.
- > Tendering advice on all financial matters.
- Compilation of accommodation, compulsory Hajj dues, PWF, Regular Budget, Income of Pakistan Houses and Entertainment Accounts.
- Preparation of Annual Budget Estimates.
- Replies of Audit Paras.
- Submission of monthly cash account to CAO.
- Maintenance of Cash Books for accommodation and Compulsory Hajj Dues.
- Reconciliation with Banks.
- Handling of payment of accommodation charges and Compulsory Hajj Dues to the owners of buildings and Maktab-ul-Vokla (Rs. 6 billion).
- Handling of PWF Budget released to D.G.(Hajj). Jeddah for every Hajj
  operation.
- Handling of Regular Budget.
- Eligibility criteria (Qualifications and experience etc.) are as under:-
  - The selectee fulfills the requirements of the post as detail in the job descriptions.
  - The selectee in the same grade as the post to be filled and officers from higher and lower grades will not be considered.
  - iii) The selectee has an over all good record of service particularly during the last five years of the service.
  - The selectee is at least a graduate or possesses the technical qualification required for the job.
  - Persons within promotion zone within the next two years shall not be considered.
  - vi) Those likely to retire during the next four years shall not be considered.
  - vii) An officer shall not be posted abread earlier.

- 3. The Ministries / Divisions are required to forward nomination of suitable candidates fulfilling the requisite criteria and also to furnish following documents in duplicate:
  - i) Bio-data-eum-CV with photographs
  - ii) Release Certificate
  - iii) No Disciplinary / Criminal Proceedings Certificate
  - iv) PERs grading for the last five years (from 2008 to 2013)
  - v) The nominee is not in promotion zone in next two years
  - vi) The nominee is not retiring in next 04 years.
  - vii) Certificate to the effect that the officer has not been posted abread earlier.
  - viii) Certificate to the effect that the officer is not beneficiary of NRO/Nab
  - Closing date for receipt of applications is 20th March, 2014.
  - 5. Only short listed candidates will be called for interview. No TA/DA will be given for the purpose.

Note:

- i) It may be noted that only civil servant are eligible for subject position.
- ii) No incomplete nominations will be entertained.
- iii) No nominations will be entertained after due date.
- iv) No nominations will be entertained without proper chennal.
