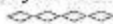

The post of Permanent Representative / Ambassador to World Trade Organization (BS-20-21) is required to be filled in by a suitable officer through a process of selection as per prescribed policy.

2. The Ministries / Divisions / Provincial Governments are required to forward nominations of suitable candidates fulfilling the requisite criteria specially all serving officers in BS-20-21 who have relevant knowledge/work experience of WTO related issues and have experience of working in/with international agencies.

Following documents are required to be furnished in duplicate:-

- a) Bio-data-cum-CV with photographs
- b) Release Certificate
- c) No Disciplinary / Criminal Proceedings Certificate
- d) PERs grading for the last five years (from 2009 to 2013)
- e) The nominee is not in promotion zone in next two years
- f) The nominee is not retiring in next 04 years.
- g) Certificate of disclosure to the effect whether a candidate/nominee as remained posted abroad earlier or not.

Closing date for receipt of applications is 03-12-2014.
