Quantity: Three million pieces per annum (July-June) provided maximum of two hundred thousand (200,000) pieces shall be allowed for each of the 21 tariff lines per annum (July-June).

Margin of Preference: 35% on all the 21 tariff lines.

Notes: Based on its Financial Year (July-June) , Pakistan will workout TRQ for the above items for the remaining period of the first year from the date of entry into force of the FTA on pro-rata basis.
