OFFICE MEMORANDUM

Subject: **ADMISSION IN 1ST YEAR MBBS CLASS IN FATIMA JINNAH MEDICAL COLLEGE, LAHORE AGAINST SEVEN RESERVED SEATS FOR REAL DAUGHTERS OF FEDERAL GOVERNMENT SERVING CIVIL EMPLOYEES – ACADEMIC SESSION 2010-2011.**

Applications are invited from the real daughters of Federal Government Serving Civil Employees for seven reserved seats (04 for Non-Gazetted and 03 for Gazetted Employees) for admission in 1st year MBBS Course in Fatima Jinnah Medical College (FJMC) Lahore during the **Academic Session 2010-2011.**

2. Federal Government Employees, both Gazetted and Non-Gazetted, who desire their real daughters to be considered for admission in 1st year MBBS Course in FJMC Lahore against the reserved seats, should route applications on prescribed Application Form, duly completed by the candidates through their respective Ministry / Division. Applications duly certified by the competent authority alongwith following attested documents of the candidates must reach to the undersigned at the earliest but not later than **20th August, 2010:**

1. F.Sc Certificate and Detailed Marks Sheet.
2. Domicile Certificate.
3. Hafiz-e-Quran Certificate duly registered/recognized.
4. Copy of Admit Card to Entry Test/Entry Test Result Card of respective province.
5. Two Passport Size Photographs (**Name in block letters at the reverse of Photograph.**)
6. Attested copies of pay slips of parent issued from AGPR of last three months i.e May, June & July

3. Following conditions shall apply for the eligibility:

- a) Adopted daughters of the Federal Government Serving Employees are not eligible for the subject reserved seats. (The forwarding authority is required to clearly indicate and certify that)
- b) Either of the parents is a Federal Government Serving Civil Employee and the applicant is his / her daughter.


- c) All candidates are required to apply to the concerned Admission Board in their respective province for admission against the open merit seats.
- d) A copy of the Admit Card to Entry Test is required to be attached with the application form.
- e) In case of selection on open merit on MBBS / BDS seat, the candidate is required to inform this Ministry immediately so that her candidature for the reserved seats for Fatima Jinnah Medical College, Lahore may be removed from the list of candidates. In case a candidate hides her selection on open merit from the Ministry, her admission shall be liable to be cancelled in FJMC at any stage of her studies, if so discovered.

4. The final authority in the selection and nomination for these 07 seats is the Ministry of Health and no petition whatsoever will be entertained on this account.

5. Application duly completed in all respects must reach to the Ministry of Health (Room No. 211, C-Block, Pak Secretariat, Islamabad) not later than **20th August, 2010**. Applications received after closing date or incomplete applications will not be entertained. The **Application Form** can be obtained from the official website of Ministry of Health (www.health.gov.pk).

6. All Ministries/Divisions/Departments are requested to kindly widely disseminate the above information amongst all the employees, and be kind enough to provide the attached Application Form to the eligible candidates.

- Note:
- (i) Autonomous Bodies / Semi Autonomous Bodies / Corporations and Armed Forces Departments / Organizations, not included in schedules I & III of the Rules of Business, 1973, the daughters of employees of such organizations / bodies are not eligible for admission against these seats.
 - (ii) Rs. 120/- will be charged from every candidate at the time of receipt of application as Courier Services charges.
 - (iii) Entry Test examination fee will be intimated to selected candidates latter on.
